## **Emissions reduction target**

To reduce GHG emissions, we are doing the following:

Convergint Technology will set targets based on per employee and/or per £M turnover, which will account for business growth. The target is:

- A 50% reduction in emissions per £M turnover/employee by 2030.
- A 90% reduction in emissions per £M turnover/employee by 2045.

## **Carbon Reduction Projects - Carbon Reduction Initiatives (ongoing)**

- Awareness and Training on reduce, reuse and recycle.
- More recycling initiatives introduced.
- Offsetting the calculated footprint for building energy, company vehicles, business travel, waste, paper & water by supporting change solutions around the world to maintain the 'Carbon Neutral Organisation' certification.



- Cut back on all non-essential flights. When air travel is required, economy class tickets will be purchased as this causes about a third of the emissions compared to business class. When booking unavoidable flights, Convergint will consider selecting a specific airline based on their sustainability credentials and how modern their aircraft fleet is. Convergint will consider switching short-haul flights to rail transport where possible (e.g., London to Paris, Amsterdam or Brussels) (e.g. London to Edinburgh or Glasgow).
- Looking into purchasing more electric vehicles and hybrid vehicles

## Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard<sup>1</sup> and uses the appropriate Government emission conversion factors for greenhouse gas company reporting<sup>2</sup>.

Convergint Technology Ltd, has assessed its carbon footprint and has achieved a successful assessment of its 2023 GHG emissions alongside a reduction in emissions per £M turnover against the previous assessment.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard<sup>3</sup>.
